#### **Definitions**

**Maple League course:** A course that is offered by one of the 4 participating universities with online, remote or distance availability for students from one or more of the 3 other participating universities to register and 'attend'.

Host university: The university delivering a Maple League course.

**Home university:** The university where the student is registered in an academic program.

Maple League visiting student: A student from one of the Maple League universities (home university) attending remotely/online a course offered by one of the other Maple League universities (host university).
